I _____, as a coach of young athletes understand that my responsibilities are of great importance and that my actions have the potential to influence the young athletes I coach. I also want Monroe Junior Dragons Sports Program to function with the highest possible standards for all of our participants. I therefore promise to conduct myself in accordance with the following code:

1. I will treat all players, coaches, parents, officials, administrators and opponents with respect and dignity.
2. I will teach my players to do the same and will lead by example, providing a positive role model.
3. I will try to place the player first and the game second.
4. I will ensure all of my players use proper equipment and that they play and practice in an environment where they are safe.
5. I will conduct my team so that all players have the opportunity to improve their skill level.
6. I will always strive for improvement by positive reinforcement, not negative comments.
7. I will never physically or verbally abuse a player regardless of the situation.
8. I will never verbally abuse an official regardless of the situation.
9. I will not tolerate unsportsmanlike conduct from myself, my players or fans. I will be responsible for the conduct of myself, players and fans.
10. I understand that if violations of this contract occur, and if after review, the Monroe Junior Dragon Board finds that a violation did occur, I may be subject to actions up to dismissal from my coaching position.
